
2. The newspaper has complied with all of the requirements to constitute a qualified newspaper under Minnesota law, including those requirements found in Minnesota Statutes §331A.02.

Sealed bids can be brought to the meeting or sent to the clerk at the address below.

**This includes:**  
1. Sanding icy roads during the winter months, including the costs of all labor, insurance, equipment, materials and other costs incidental thereof.  
2. Snow plowing during the winter months, including the costs of all labor, insurance, equipment, and other costs incidental thereof.  
3. Road grading including the costs of all labor, insurance, equipment, materials and other costs incidental thereof.  
4. Culvert repair, replacement, and cleaning; and Right of Way maintenance, including the costs of all labor, insurance, equipment, and other costs incidental thereof.

Bid is to include the size and make of equipment available for the maintenance described and the hourly rental cost of said equipment. All bids are to be in a securely sealed envelope, with an explanation of what the bid is for on the outside of the envelope. Bids shall include a current Certificate of Liability Insurance. Invoices for completed work shall include dates, work completed, where completed,

or where materials were delivered to. Oronoco Township reserves the right to reject any and all bids, and to waive minor irregularities in the bidding process.
