All membership dues must be sent to the MAT office upon receipt of payment from your township on or before May 1. DO NOT send your MAT dues to your county unit.

According to the Membership Dues Payment and Member Suspension Policy, please note the following:

- If MAT does not receive a member town's dues payment in full within 90 days of January 1,
  MAT will send a reminder notice to the town clerk.
- If MAT does not receive payment in full of the member town's dues within 120 days of January 1, MAT will send to the town clerk and chairperson a notice of delinquency and suspension. Bylaws, Art. IV. Sec. 2. A copy of the notice will also be provided to MATIT.

Following May 1, delinquent townships will be removed from our membership list; the 'Minnesota Township Insider' magazine will be discontinued immediately, and all other membership benefits will be terminated.
